2024 LEHIGH COUNTY CONSERVATION DISTRICT SCHOLARSHIP AWARD



GOAL: The 2024 Lehigh County Conservation District Scholarship Program has \$2,000 in funding available for a Lehigh County High School student(s) pursuing an undergraduate degree in environmental science, agricultural science or a related field of study.

STUDENT REQUIREMENTS:

- 1. Applicant must attend a Lehigh County High School (public, private or charter) and be a **2024** graduate.
- 2. Applicant must be enrolled at a Pennsylvania College or University as a full-time student in the fall semester of 2024_and declare a major in environmental science, agricultural science or a related field such as natural resource management, forestry, conservation biology or environmental education. A copy of the college acceptance letter must be included in the application.
- 3. Write an essay on all of the following four topics:
 - Why the applicant is pursuing a degree in the environmental field
 - How the money will be used
 - Identify one current environmental issue, how it affects the population, and what solution(s) you would create to address the issue
 - What your future plans consist of
- 4. Length of the essay is five hundred (500) words maximum.
- 5. Create the essay in Microsoft Word with a Times New Roman font and a fourteen (14) point format.

- 6. Applicant is required to send two letters of recommendation from teachers. One letter must be from the applicant's current High School science teacher and the other from another current teacher. Each letter must be printed on official school letterhead, signed and dated by the teacher, and include contact information.
- 7. Applicant must have a minimum cumulative GPA of 2.5. The applicant's High School transcript must be included in the application packet.
- 8. Applicant must send a list of accomplishments achieved during their High School career using the resume activities form.
- 9. Entries must be signed and dated by the applicant, parent or guardian, High School principal, and a current science teacher to verify that all contents are correct.
- 10. Applications must be received at the Lehigh County Conservation District's office by May 1, 2024. Send the application packet to:

- 2. The Scholarship Committee will make recommendations to the Conservation District's Board of Directors.
- 3. The Board of Directors will select the 2024 scholarship recipient(s).
- 4. The scholarship(s) will be paid directly to the applicant(s) at the beginning of the fall 2024 semester.
