### > Cafeteria Update

- o SHINE Program Meal Contract
  - Starts on or about October 6<sup>th</sup> at SE and PE
  - Approximately 50 students total (25 at each site)
  - Supply healthy meals to these students for dinner (4:05 pm) Monday through Thursday
  - Must meet the same guidelines as the NSLP and CEP (which is the branch that we are under for this school year) protein, fruit, vegetable, grain, and milk.
  - This program is at no cost to us.
  - We submit weekly meal counts and bill LCCC \$4.10 per meal served our average cost per meal is \$2.50, paper is \$0.35 cents and labor .95 cents for a total of \$3.80. Profit of \$0.30 cents per meal on average (60\$ per week/\$240 per month/ \$2,160 per year)
  - They conduct annual audits to ensure the food is being prepared in a safe manner. We will be meeting with a woman by the name of Michelle during the month of September to review layout of kitchen, where paper supplies are located, hairnets, aprons, gloves, how to turn on and off warmers for hot items, etc.
  - Copies of our most recent health inspection reports have been provided to LCCC
  - We are looking for board approval for moving forward with the Sponsor-to-Sponsor Agreement between Northern Lehigh and LCCC SHINE after school program for the upcoming 2022-2023 school year.
