<u>Legislative Report</u> – Mr. Gregory S. Williams reported the Federal Government is releasing additional money to Pennsylvania under the ARRA Act. Additionally, the senate narrowly approved an education jobs fund bill which will direct money to states to save teaching have been illuminated across the country. NSBA estimated that 4,000 teaching jobs in be saved if the House does follow through and approve the bill and the President signs

Williams read from a PSBA document which stated Governor Ed Rendell and legislative leaders have been scheduled to meet next week to begin discussing possible budget cuts. However, with today's news of Senate passage of the bill and anticipated House passage of the bill, and with the addition of approximately \$390,000,000 education jobs funding for the state, further cuts to education may no longer be needed. PSBA is sounding a positive or hopeful note that some of the things happening at the Federal level will save the state budget.

<u>Lehigh Carbon Community College</u> – Mr. Mathias J. Green, Jr. reported that today was the annual foundation golf/tennis event run by LCCC's foundation to raise money for scholarships. There are approximately 40 more golfers this year and a few more sponsors. Last year they rose about \$60,000 and they are hoping to do a little better this year. The majority of this money is used for scholarships at LCCC.

<u>Solicitor's Report</u> – Attorney Charles Stopp reported in June the Board settled on a bond issue at closing a check was issued to Steckel and Stopp Law Offices for local solicitors work. Federal <u>and Other Programs Update</u> – Mrs. Karen A. Nicholas reported that the summer reading camp for students in Kindergarten through 3rd grade has been completed. There were approximately 52 students that participated. Teaching staff representatives and administration have begun their math curriculum mapping for Kindergarten through 12th grade. They will

<u>Business Manager's Report</u> – Mr. Jeremy G. Melber stated on the agenda for approval this evening are bills for payment and per capita abatements. He further stated that real estate tax bills have been issued and payments are coming in. Administration was told that the 2011-2012 budget season will begin in September this year instead of November because this is the year the stimulus money will go away, health insurance will increase and we will be seeing the first spike with the PSERS pension account. Lastly, the Board did issue the bond in June for \$11,000,000 and it is in a very conservative investment account that we are receiving a little yield on. At September's Finance Committee Meeting the board will need to start discussion on the second bond issue.

Mr. Richard Oertner – Washington Township – He thanked the Board for the opportunity to speak this evening. He will try to keep his comments brief. He has a few things he has anguished last 12 days. First of all he got caught up goofing around with the kids. He acted like a peer of the adult he should have been. That was a huge mistake on his part. He is very sorry for his actions. He is sorry for taking up the Boards time this evening. He is personally embarrassed that he is here in front of the Board. He recognizes the safety issue and he made a mistake in transporting one of his players on his car improperly to his house. He wishes he can take it back but he can't. Does he think there should be some kind of action taken by the Board of the district? The answer is he seriously understands the issue and how serious it is. Does he believe he should be terminated as head coach of the basketball team? He has to tell you he thinks it is a harsh penalty. It is one of the reasons he respectfully decided not to resign. He is still hopeful there is another way to deal with this issue. Since this mishap happened he has taken some actions. He has apologized to the parents, talked to the player about how wrong coach was, apologized to Mr. Michaels and Mrs. Yadush. He also wrote an apology letter to all the Board member. What he has not done is he hasn't contacted an attorney. He hasn't talked to the media. He has not talked openly to the community about it and he has not talked negatively about anybody in the district involved in the decision. He did not have a parent meeting. Some parents and players asked me what they could do to help me. I told them to support me in any way they could. He is still hopeful this can be handled in another way rather than losing his basketball job. If this is resolved and he remains coach he recognizes that he needs to have a positive working relationship with the district and move forward. Doing any kind of public talking to the media or me saying negative things certainly would not help this relationship. This is not the way he normally acts with his players and he has 10 years of coaching experience to prove it. He has provided the Board with a letter, a list of his coaching experience and activities with the players, and also activities he is involved with in the district. There has never been a safety issue before. The same letter he sent also includes details about his job

Why did I went working with challenged kids at the IU and his years of volunteer service with the Special It should be clear in this letter that he has a commitment to the kids and to their education. not accept the request by administration to resign? Have you heard anything negative about the way the program is run that has caused any concern for safety? Likewise, have you heard anything positive in the community about the basketball program?
